## To: People Interested in the Crystal Springs Hatchery Program

Bonneville Power Administration (BPA) will be preparing an environmental impact statement (EIS) to analyze the effects of the Shoshone-Bannock Tribes of the Fort Hall Reservation's (Tribes) proposed Crystal Springs Hatchery Program. The U. S. Forest Service (USFS) Salmon-Challis National Forest will be a cooperating agency on the EIS. This letter briefly explains what is being proposed, outlines BPA and Forest Service's environmental review process, and invites you to public meetings, and to comment on the proposal.

**Proposal** - BPA is proposing to fund the Tribes' Crystal Springs Hatchery Program. The program would involve the construction and operation of a hatchery to rear Snake River spring/summer Chinook salmon and Yellowstone cutthroat trout and construction of two fish trapping (weir) facilities (*please see the enclosed map*). The hatchery would be constructed at the site of an obsolete trout hatchery on Crystal Springs in Bingham County, Idaho. The weirs would be located on USFS land in Idaho; one on the Yankee Fork of the Salmon River at the Pole Flat Campground in Custer County, and one on Panther Creek in Lemhi County. The USFS would decide whether to grant a special-use permit for construction and operation of the weirs, relocation of a USFS road, and construction of support facilities (RV pads).

Program operations at the hatchery would include incubation and rearing of up to 1,000,000 juvenile spring/summer Chinook for release in the Upper Salmon River subbasin to enhance fish populations available for harvest and to aid in establishing a naturally spawning spring/summer Chinook population. The weirs would be used to collect adult Chinook for broodstock. In addition, the hatchery would produce up to 5,000 Yellowstone cutthroat trout for release and harvest in an oxbow lake on the Ft. Hall Reservation.

The proposal has been recommended for funding by the Northwest Power and Conservation Council and would help BPA meet responsibilities under the Northwest Power Act and the 2008 Shoshone-Bannock Tribes' Fish Accord Memorandum of Agreement.

**Environmental Review** - BPA, in cooperation with the USFS, will prepare an EIS pursuant to the National Environmental Policy Act to assess the potential impacts of the proposed action and identify ways to reduce those impacts. The EIS will analyze the proposed action, an alternative to fund the hatchery only, a no-action alternative, and any additional viable alternatives brought forward during the scoping process. During this process, BPA and the USFS will work with federal, state and local agencies, tribes, landowners, and interest groups.

**Public Meetings** - We have scheduled three open-house style public meetings where representatives from BPA, USFS, and Shoshone-Bannock Tribes will be available to answer questions and take comments about the scope of the EIS.

**Forest Service Objection process** – The USFS's decision will be subject to the objection process (36 Code of Federal Regulations [CFR] 218)—the proposed project implements land management plans, is not authorized under the Healthy Forest Restoration Act, and is subject to 36 CFR 218.7 parts (a) and (b). The objection process will occur after the release of the final EIS, which will include a draft Forest Service Record of Decision (see Schedule above).

In order to be eligible to file an objection, specific written comments related to the project must be submitted during scoping, during the draft EIS comment period, or during any other comment period that could be provided on this EIS (36 CFR 218.5). Individual members of organizations must submit their own comments to meet the requirements of eligibility as an individual. Objections received on behalf of an organization are considered as those of the organization only. Names and addresses of those who comment and/or file objections will become part of the public record.
